# 2021 Pesticide Discharge Management Plan – Final-Season Update by RAL Ventures, Allan Loe (Informational only)

Allan Loe presented the Mosquito Surveillance and Control Report for 2021. This final season report included, but not limited to, program objectives (mosquito control), Larval Surveillance and Control, Adult Mosquito Surveillance, Service Requests (150 requests and maps), Adult Mosquito Control Activity, 2022 equipment and personnel updates, Larval and Adult Surveillance Data Sheets by Districts, Trap locations by city and county, Ground Adulticide Applications and Maps, and 2021 West Nile Virus Surveillance Summary of the State of Idaho, including Teton County.

## **Resolution to Reserve Forgone Funds – The Resolution would reserve \$1,543 in the Fiscal Year 2022 Budget, as foregone taxes, for use in a future year.**

The County Director, Ronn Carlentine, explained that the Resolution will reserve \$1,543 in the Fiscal Year 2022 budget. This amount represents an unused levy amount that was not included in the 2021 budget, and therefore can be used in future years. The Resolution will be delivered to the County Clerk so that the President, Dan Burr, can execute the document with the Clerk to attest his signature.
